Indoor Activity Centre**INDOOR PLAYGROUND RULES:**

1. All children must be supervised by an adult or person 14 years of age or older.
2. Large play structure is recommended for children 3 years of age and older.
3. At no time should children climb the exterior of the play structure, railings or netting.
4. No shoes allowed. SOCKS MUST BE WORN AT ALL TIMES.
5. No toys allowed in the Play Structure.
6. No hanging from the Bumper Bags.
7. No rough or dangerous play.
8. No sharp objects within the play area.
9. No food, beverages or chewing gum allowed in the play areas.
10. Food and beverages must be kept at tables provided.
11. Please clean up after yourself and your children.

Indoor Activity Centre**FLOORBALL/MINI STICK RINK RULES**

1. All children must be supervised by an adult or person 14 years of age or older.
2. No wet or soiled footwear.
3. No toys allowed in the Floorball/Mini Stick Rink.
4. No hockey sticks or pucks allowed. Please use the sticks and balls provided, or bring your own.
5. No high sticking.
6. No climbing on the boards and netting.
7. No food, beverages or chewing gum allowed in the Floorball/Mini Stick Rink.
8. Please do not remove provided equipment from the area.

Membership Terms & Conditions

1. The Membership Swipe Card remains the property of the Viking Families 4 Fun Society (VF4F) and must be surrendered upon request. Membership Swipe Cards must be returned to the Town of Viking office, located in the Viking Carena Complex (Facility) at the expiration of your membership.
2. VF4F will apply a \$15 fee in the event a Membership Swipe Card is lost, damaged, or needs to be replaced.
3. The Facility or VF4F will not be held responsible for any accidents or incidents which may occur within the Facility unless caused by lack of due diligence by the Facility Staff or VF4F Society, or structural damage.
4. The Membership Holder assumes responsibility for any damage to the Facility or VF4F Indoor Activity Centre caused by the Membership Holder and anyone else who uses their Electronic Swipe Card to enter the Facility regardless of the circumstances. The Membership Holder also indemnifies the Facility, the Town of Viking and Viking Families 4 Fun Society from any action, or claims for loss, injury or damages incurred in the Facility or on the grounds surrounding the Facility. The Membership Holder must report any lost or stolen Electronic Swipe Card immediately to the Facility to avoid responsibility for any damages caused by false use of Electronic Swipe Card.
5. The Membership Holder understands the Indoor Activity Centre is available for Private Bookings which gives the Private Booking exclusive use of the area. If the Indoor Activity Centre is not booked through a Private Booking, the Membership Holder cannot refuse entry to the any other Membership Holders.
6. The Membership Holder is responsible to follow all Indoor Activity Centre Rules and Membership Terms & Conditions outlined in this Membership Application and Contract. Any Membership Holders found to have disobeyed any rules outlined in this package or posted within the Facility will have their Membership suspended or revoked, with no refund.
7. The Membership Holder is responsible to ensure the Membership Swipe Card is used for their immediate household members and guests. The Membership Holder understands the Family Membership cannot be shared between households. Misuse and sharing the Electronic Swipe Card with other non-members of the household will result in the immediate suspension of the card to the VF4F Indoor Activity Centre, with no refund.
