

Dear User Group,

Please read the following and share with your team/user group:

By signing this user agreement and entering our facility, **you are releasing the Viking Carena and its employees from any liability due to Covid-19**. Full responsibility falls upon each person who enters the facility.

All patrons who wish to enter the Viking Carena during the declared pandemic understands the increased risk of Covid-19. You will enter our building at your own risk.

Please be aware that as regulations are updated by Alberta Health Services, the Viking Carena reserves the right to adjust/cancel ice rentals accordingly.

Each team must have a Team Representative at every ice time who is responsible for ensuring all rules are followed. **REPRESENTATIVES: PLEASE FORWARD THIS EMAIL TO ALL YOUR PARTICIPANTS AND ENSURE THAT THEY READ IT.** In the case of an athlete becoming ill or testing positive for COVID-19, this representative must keep a list of all players in attendance at each ice time in-case contact tracing is needed for AHS.

**EVERY PERSON THAT ENTERS OUR FACILITY MUST DO THE COVID-19 SELF CHECK TEST DAILY. See link at the end of this message. If ANY symptoms are present, do not enter the building.**

AHS has recommended that you download and use the ABTraceTogether APP.

Please follow the following guidelines:

1. All participants will enter through the EAST side of the building through the players entrance further to the SOUTH. Players will then exit through the NORTHEAST door. Follow signage in the hallway.
2. Game play is permitted provided the teams meet government and league regulations regarding cohort groups. Currently the allowance is 50 skaters and 100 spectators.
3. We now allow players to dress in the dressing rooms, but groups can not enter the facility more than 30 minutes prior to their scheduled ice session unless approved by facility staff.
4. We are asking that **spectators stand in the upstairs viewing area and only use the bleachers which have not been blocked with chains and signage**. We will be providing some chairs for elderly or those with disabilities to sit during the ice sessions.
5. We will be sanitizing dressing rooms between sessions so once you are done on the ice you have **30 minutes** to vacate the room. You must **stay in the dressing room until the start of your ice time**. Please keep your physical distancing as you head to the ice and as you exit the facility. **Showers are now available for arena dressing rooms**

**(gym change rooms remain closed).** After leaving, please do not loiter in the entranceways/exits or in the parking lot.

6. Vending machines are now available but water fountains will not be in operation. Please fill water bottles at home.
7. **NO SPITTING!**
8. Coaches and team representatives are responsible for their equipment (rink boards, pylons, pucks, etc.) and the sanitization of that equipment. Any equipment that is left behind will be discarded unless you contact our staff in a timely manner.
9. Hand sanitization stations can be found throughout the facility.
